Due to this unprecedented health crisis our school Administration and Staff are working diligently to develop, modify and release both short-term and long-term academic plans to be used support our students during this school closure. At this time, we are not operating a formal virtual school with formal daily check ins. However, we will be closing Quarter 3 early and releasing work each week that school is closed. At this time, the work being released is supplemental in nature. It will not be used as a formal grade.

The initial academic plan is as follows:
